



2016-17 LIFE CHRISTIAN ACADEMY TRANSPORTATION COMMITMENT

This agreement is between the Life Christian Academy Transportation Office and the family listed below. This is a commitment to follow all guidelines and direction for bus use. If there is a reason for discontinued use of this service, please notify the Life Christian Academy Transportation Office.

- This service is provided for registered kindergarten through grade 12 riders only.
- Children will be dropped off at the designated bus stop and no longer the responsibility of Life Christian Academy. Please have someone there to pick up your child.
- Bus drivers must leave the stop FIVE minutes after the designated pickup/drop-off time.

PLEASE SELECT ONE OPTION OF SERVICE

OPTION 1- Full Ridership Privileges-Families will be charged at the rate of \$165.00 per calendar month that a student wishes to ride the bus. If a family has more than one student riding the bus, the monthly charge for the entire family is \$215.00 a month. This option is available on a monthly basis (September-May) and will be charged to your student’s account. If your student rides for any part of the month, the monthly charge will be incurred.

OPTION 2-Half-Time Ridership-This option is available to families whose students are involved in afterschool programs and who are only riding one way. The monthly rate for this option is \$100.00 per calendar month that the student is involved in our afterschool programs. This option is available on a seasonal basis (fall, winter, spring), and will be charged to your student’s account. At the end of his/her activity season, this option will revert back to option one (1), and be charged out at the full ridership fee of \$165.00 per month.

OPTION 3-Per Ride Charge-A student can purchase a single bus ride pass for \$5.00 from the Transportation Office. A parent signed bus permission slip must be presented with cash or check in order to receive the ticket to use the bus. It will not be possible to charge an account or credit card for this option.
